

APPENDIX 3G - LONG TERM INCENTIVE OPTIONS ISSUED TO CHIEF EXECUTIVE OFFICER

Melbourne, Australia, 16 April 2021: BARD1 Life Sciences Limited (ASX:BD1) (**BARD1** or the **Company**) advises that the Board have resolved to grant a further 166,667 unlisted options to Chief Executive Officer, Dr Leearne Hinch, under the Company's Incentive Option Plan, and pursuant to Dr Hinch's acceptance of an Invitation Letter issued.

BARD1's Incentive Option Plan was approved by shareholders at the Company's 2019 AGM.

The issue of this tranche of options was advised in the Company's ASX announcement dated 3 October 2019, titled "Long Term Incentives for Chief Executive Officer". BARD1 undertook a 1 for 30 ordinary shares held consolidation in December 2020, therefore the number of options proposed to be issued in that announcement reduces to 166,667 (5,000,000 divided by 30).

A high level summary of key terms of the options are as follows:

Vesting conditions	Options will vest on issue.
New issues	Options do not have the right to participate in new issues of ordinary shares or other securities in the Company, including by way of bonus issues, rights issues or otherwise, unless the options have been exercised into ordinary shares before the record date for determination of entitlements to a new issue.
Reorganisation of capital	In the event of a reorganisation of the Company's share capital, the Board will review and modify the terms of the options if required by, and in accordance with, the Listing Rules.
